Pedestrian path along #97 Thames Side

Due to the 'lockdown' and the apparently heavy foot traffic through the above mentioned footpath, Emily and James thought it necessary to put a bicycle lock on the pathway gate. For those still unaware of the Gate Code please contact us.

Last week, I emptied the Doggie Bins on both Penton Hook Island and Silvery Sands, I had the very welcome assistance from Bernie. Peewee helped a bit also . Spelthorne Council very kindly agreed to collect the bin bags from the bottom of Penton Avenue, which was done. The ones on the Lock, go into the Lock bins.

Until we locate the EA to find out what is happening with the service, I will continue to monitor. However, if any of you can help by picking up any rubbish/recycling around the Dog Poo Bins, this will be very much appreciated. Thank you.

Anti Social Behaviour in our area
